1. Call to Order

- a. Roll Call Meeting was called to order at 4:30 pm by President Matt Bunch. 2. Communications

- a. Correspondence Brian received concerns about the fencing around the building project that restricted the access to Rosebrook and Ely Buildings during horse competition. Brian hade the construction company shrink the perimeter of the fencing to accommodate the concerns.
