Have applied for the State of Oregon Renewable Energy Grant with the help of Kelly Harms.

Also applied with the Mt. Hood Territory grant for new bleachers in the Rodeo arena.

Horse fair went well. The new 4H horse superintendent was organized and followed up with Brian with asking what they needed to work on for next year.

Maintenance/grounds are working on "greening" up the lawn areas by watering the various areas.

Performance Audit will be conducted this year along with formal financial audit by county.

Fair Board Individual Reports - Kristin went to Harefest and had a great time.
 It was well organized and everyone was having fun.

Raeline went to Mike Coreless's Memorial service and was asked to speak on behalf of the Fair Board on Mike's involvement with the fair. Many fair people were there to honor Mike along with the tremendous number of fire departments that Mike knew.

- c. Fair Board Committee Reports
  - Update on building project Water lines were flushed and pressure tested. Concrete and rebar for the floor will be poured before fair.
     Footing for main beams are being placed.
  - ii. Rodeo Committee Loren reported that the Rodeo Volunteers are preparing the grounds and facilities for a great Rodeo. Loren will also present the Blue-Ribbon award to the family of Doc Harms at his memorial service. Queen Naomi gave a report on all that she has attended or participated in.

She was also awarded the Best Queen of the Floral Parade. She is doing a wonderful job. Working on the budget for next year, pressure washing the rodeo area and new Fiber optics are being installed. There will also be work parties scheduled for August 2, 9 and 10. Anyone is welcome to help.

d. Commissioners Report - Laura reported that we are on track to to receive a loan from the County for funds to complete the building. Details of the repayment plan/amount is being worked out.
